Find below our scientific opinion issued upon a request dated 5 March 2012 we received from Kazım Yiğit Akalın, attorney-at-law, representing Halil İbrahim Firtına.

QUESTION 1

- a) We observed in 22 (see list in Annex B) of the Microsoft Word files that are the subject of the action (see CD-ROM Annex A) that the information "Last saved by" was not the same as the last user in the user file paths. Is this possible? How would you explain it?
- b) What would be your comments on this matter in terms of reliability and integrity of evidence?


ANSWER 1

- a) The format Microsoft Word, like many other electronic document formats, does not contain any cryptological method (hash summary, electronic signature etc.) that would ensure integrity of data. Therefore, it is possible to modify any part of a document or to destroy a document or to create it in a totally deceitful way by means of special software or a standard dual file editor. It is not possible to detect such modifications or to verify the authenticity of a document. The metadata contained in the document such as the writer, last saved by and date as well as the content of the document can easily be modified.

The Word format keeps in the metadata information such as the user who created the document and the user who last saved the document, the dates of these operations and the file path where the file is kept. The user file path information provided in the annexes is a special field used in MS Word 9 and earlier versions where information about the last 10 writers is kept. In subsequent versions, Microsoft gave up using this field due to privacy reasons. In a standard use, the MS Word 9 software updates every time the document is saved the information about the last 10 writers, the file path information, the user who last saved the document and the time of last saving. Therefore, one should expect these two items of information written by the MS Word software to be identical.

Such a contradictory situation may happen when the metadata of the files has been altered by means of another software program. MS Word 9 and other office software programs that were available at the time of MS Word 9 and newer versions of MS Word reset the information of last 10 writers. The version MS Word 9 records this information coherently. Therefore, it is possible that the alteration was carried out in order to modify particularly the metadata.

- b) Unlike handwritten documents or documents bearing a material signature, it is possible to modify electronic documents easily and without leaving any trace. For this reason, the personal information contained in the time and metadata information of electronic documents is not reliable. In the event a document is discovered in an environment that cannot be associated with a person (flash memory, CD, DVD,



anonymous mail etc.), the ownership information is totally unreliable. Just any person may have produced the document.

To be able to rely on ownership information about the document, the document must have been discovered in a computer used by the person in question privately or in a computer account in accordance with the procedures of judicial computer science. In the event the document is discovered in the manner described above, (the authorities) must take into account the possibility that third parties may have had access to the computer and to the account physically or through network and the level of security of the operating system and of the network. (The authorities) should consider the possibility that third parties may have intruded into the computer and placed in it files by having access to the computer physically or through network or using viruses or taking advantage similar security gaps.

The discrepancy that is the subject of the question shows that the documents were changed in a way other than ordinary use (such as a person opening, editing and saving, copying, re-opening and saving the document), which causes the documents to lose their quality of being reliable evidence.


Question 2

In 113 (see list in Annex C) of the Microsoft Word files that are the subject of the action (see CD-ROM in Annex A), there is information referring to a data series at the addresses 5CA HEX and 5D2 HEX in the data structure. When these files are opened using the Microsoft Word 9.0 application and saved in a location in the hard disk of the computer, the information in question and the data series it refers to are automatically deleted from the file.

- Under which conditions does such a thing occur?
- In the light of the results of your examination, is it normal that the word files figuring on the list in Annex C contain the data series in question?

ANSWER 2

- The addresses in question correspond to the field FCPGDOLD in field 3CA in block FIB at the beginning of the field named "Worddocument stream" in the MS Word DOC binary format. According to the definition of this field in the documents of the firm Microsoft, there are two reference addresses in the fields 3CA and 3D2 and the fields 3CE and 3D6 contain the length of this data located in these addresses. The MS Word 9 application uses the field in question as a temporary buffer area for calculation of page structuring. Therefore, there is data in this field when the document is open in the memory and when the file is saved in the disk, this calculation becomes firm and the fields 3CE and 3D6 that indicate the data length are reset and saved. Something that is not observed in the new versions of the software is the fact that the information in this field is in some cases reflected on the saved file.



The version MS Word 9 behaves differently depending on whether the file is written on a disk or in a different medium such a USB memory. It resets this field when it writes on a disk and reflects the temporary information in this field on the file when the file is saved in a USB memory.

It is impossible for anyone other than the members of the development team of the manufacturer, i.e. the USA-based company Microsoft, to know the details of and the reason for this behaviour. But it is a fact that we observe and aware of such behaviour.

This behaviour does not occur when the file is taken out of the disk, edited and resaved. It may have occurred in such cases as the file being written in a USB memory and afterwards copied on a disk. But similar results may occur when a file saved this way is modified afterwards and written on a disk with a software program other than MS Word. The last saving field of the files provided in the CD annexes seem to be the hard disk. This constitutes a contradictory situation as regards the field where the files are saved in metadata and the behaviour of the software used.

b) It is not known whether there are other conditions that may lead to such a situation or whether the software exhibits the same behaviour in other specific situations. But we may say that the files have undergone a process different from a normal process of using and creating a file and were modified during this process.

Find below the list of those files from among the files in the CD ROM where this situation was observed. The fact that the fields 5CE and 5D6 are not zero indicates the mentioned situation. The values are given in hexadecimal form.
